



Terms & Conditions

It is mutually agreed that the following terms of agreement form an integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by both Pink Milk Photography and the client, in writing.

Booking Deposit

A deposit of 50% of the sitting fee is required at the time of booking, together with a signed contract. Dates are reserved only when the deposit is paid by cheque. Please make cheques payable to Amanda Crowther. An unconditional refund policy exists for a period of 14 days from receipt of this contract and payment.

Balance Payment

The balance of the sitting fee is to be paid on the day of the shoot. Payment for prints is made after the shoot at the time of ordering.

Cancellation

If Pink Milk Photography have to cancel this contract for reasons beyond their control (death, injury, sickness, etc), their liability shall be limited to a full refund of all monies payable.

After a period of 14 days from the date of signing the contract, as compensation for loss of income for Pink Milk Photography, the following charges apply as a percentage of the total fee due, dependent on the number of days before the shoot:

7 days or less – 100%

8-90 days – 50%

Should the cancelled shoot turn out to be a postponement then, subject to Pink Milk Photography's availability, all money paid may be applied to the new shoot. In this case, the total fees chargeable shall be the fee which applies at that time.

Parental Responsibility

Pink Milk Photography requires a parent or responsible adult to be present at all times during the shoot. This person is responsible for the child's safety at all times.

Creative License

Pink Milk Photography shall be granted creative and artistic licence in relation to the choice of locations and poses used. Pink Milk Photography's judgement on photographic style and the number of photographs taken shall be deemed correct. Subject to changes of the weather and the availability and willingness of subjects, Pink Milk Photography will do their best to honour requested photographs, but do not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement.

Copyright

The 1998 Copyright, Designs, and Patents Act assigns copyright to Pink Milk Photography. You may not copy the photographs taken under this contract, or allow copies to be made photographically, electronically, or by any other means. Pink Milk Photography retains the right to use all photographs taken under this contract in any manner at any time and in any part of the world for the purposes of advertising or otherwise promoting their work.



Proofs

Contact sheets will be posted to the address you provide within 14 days of the shoot, unless otherwise arranged and confirmed in writing.

Force Majeure

In the unlikely event of a photographic failure, injury or sickness beyond Pink Milk Photography's control, their liability shall be limited to a full refund of all monies paid. Your statutory rights are not affected.

Complaints Procedure

Please address any complaints to Pink Milk Photography, either by email or post. Pink Milk Photography would endeavour to respond to any complaint within 7 days.

Privacy

Pink Milk Photography will store your name and shoot details on a private internal database. These details will not be made available to other companies or individuals.
